To be eligible, organisations must have, as their primary purpose, the arts and entertainment. The grant opportunity commences 31 August 2020 and will close to applications on 31 May 2021, subject to allocation of funds. Applications will be accepted at any time between the opening and closing dates for the program.

The objective of the BLER Fund is to support economic and social recovery at a local and regional level in areas impacted by the 2019- 2020 bushfires. The BLER Fund will support job retention and creation in these regions, strengthen community resilience and reduce the impact future natural disasters will have on our communities. The majority of funding should be committed to the areas most impacted by the fires.

The grant funding for individual projects is dependent on the project type.

• Infrastructure projects must seek a minimum of \$400,000 with a maximum available grant of \$20 million.

• Environmental projects including rehabilitation, remediation and resilience improvements must seek a minimum of \$200,000 with a maximum available grant of \$4 million.

• Programs, including social, business and environmental education initiatives must seek a minimum of \$200,000 with a maximum available grant of \$4 million.

Description

Funding available for short-term projects for high and moderate socially impacted local government areas that were disaster-declared during the 2019-20 bushfires.

The grant funding for individual projects is dependent on the project type.

• Infrastructure projects must seek a minimum of \$400,000 with a maximum available grant of \$20 million.

• Environmental projects including rehabilitation, remediation and resilience improvements must seek a minimum of \$200,000 with a maximum available grant of \$4 million.

• Programs, including social, business and environmental education initiatives must seek a minimum of \$200,000 with a maximum available grant of \$4 million.

This program will focus on the short term, community led recovery of communities that were impacted by the Black Summer Bushfires in 2019/2020.

Funding will support the resilience, rebuilding and strengthening of the social fabric within communities, with priority given to community-led activities that promote: People, Supporting individual recovery and resilience building, Social, Supporting community connectedness and recovery of organisations, Economic, Supporting community initiatives that assist in the economic restoration of communities, Environmental, Supporting the conservation and reestablishment of the natural environment

#### Description

This program aims to provide financial assistance for bushfire-affected people in financial hardship.

The cash grants available are:

- Emergency grant: Up to \$20,000
- Injury grant: Up to \$7,500
- Primary residence repair grant: Up to \$5,000
- Re-establishment grant

Eligible applicants include:

- Emergency grant: People whose primary place of residence has been destroyed or is permanently uninhabitable because of the bushfires.

- Primary residence repair grant: Home owners whose primary place of residence was structurally damaged by the fires, to make sure their home is safe to live in or return to.

- Injury grant: People who have spent two days or more in hospital as a result of physical injuries or mental health issues directly caused by the bushfires since July 2019.

- Re-establishment grant: People who lost their primary place of residence in the bushfires to help have somewhere safe to live in the medium-to-long term.

Note: People who have already received a Red Cross grant may also be eligible for the new additional support grant if they are still facing financial hardship.

The bushfire recovery grant of up to \$50,000 is to help pay for costs associated with the clean-up and reinstatement of a small business or non-profit organisation's operations.
